RSEA LEGISLATIVE & GOVERNMENTAL AFFAIRS DIRECTOR'S MESSAGE



One of the most oft-asked questions that I receive, second only to questions about Social Security Offsets—WEP and GPO, is "when are the retirees going to get a COLA (cost of living allowance)," also, officially

known as a permanent benefit increase (PBI).

The volume of questions about this topic actually spiked in number in recent weeks when it was learned that state classified employees were receiving market adjustments or pay raises in July, 2020 causing retirees to ask once again, "when are the retirees going to get a raise?"

In fact, LASERS was kind enough to put together a short (2-minute) special video presentation explaining the COLA process at RSEA's request. We posted the video on our RSEA Facebook page https://www.facebook.com/watch/?ref=ex ternal&v=602347923783509 and also sent out an e-blast with the video. Thanks to LASERS for assisting RSEA on this! For the record, the last LASERS retiree COLA was 1.5% and was granted by the legislature on July 1, 2016 to eligible retirees.

Also, adding to the curiosity about COLA's were two legislative instruments this past legislative

session: SR-15 (Senator Ed Price) and HR-21 (Representative Lance Harris). Both resolutions are virtually identical in wording and intent and basically "urge and request the state retirement systems to report (by December 1, 2020) to the legislature on alternative methods for providing permanent benefit increases to retirees." We are anxiously awaiting the report(s) in hopes that retirees will receive some type of relief from the COLA "drought" we are currently experiencing at this point in time. So, with the above background information in mind, what is the present COLA process and when are the retirees allowed to get a COLA?

The process for System-generated COLAs is as follows: COLA's are granted by the Legislature. They are funded through excess investment returns and paid by LASERS through the Experience Account. COLAs are not guaranteed and the amounts vary. They are paid automatically to eligible retirees. You must have reached age 60 as of June 30th of the year the COLA is authorized by the legislature and you must have been retired effective June 30th of the previous year. COLAs are limited to every other year (until the system is 85% funded) and are limited to the first \$60,000 of benefit (indexed to the CPI-U as of July 1, 2015).

If the above criteria are met, the following must still take place before a COLA can be granted:

1) The Experience Account must have a balance sufficient to fund the COLA on an actuarial basis. The LASERS Board of Trustees must recommend a COLA to the legislature when funds are available. Legislation to grant a COLA must pass by at least a two-thirds vote of both chambers of the legislature and signature of the Governor. These were set by the Legislature in 2009.

*Note: There is no age requirement for disability retirees to receive a COLA. There is also no limitation on the number of years a retiree can go without a COLA and COLAs are not retroactive. The whole process is driven primarily by the by the system's investment returns, coupled with the rate of inflation, and legislation approved by two-thirds vote of the legislature, and approval of the Governor.

The following benefit payment dates fall on a weekend or holiday, which could affect receipt of your funds:

- November 1, 2020 is a Sunday;
- January 1, 2021 is the New Year's holiday.

Direct deposits are guaranteed to be in your bank or credit union on the first day of the month. Be aware that if the first falls on a weekend (Saturday or Sunday) or holiday, funds may not be available until the following business day. In these cases, please contact your financial institution directly for information on when your funds will be made available to you. That decision is made by your financial institution, not LASERS. If you have not received your monthly benefit payment by the first business day of the month, please contact LASERS in Baton Rouge at 225.922.0600 or toll-free at 800.256.3000.

ALLEN H. REYNOLDS



Allen Hale "Haley" Reynolds, age 73, passed away peacefully on Saturday August 15, 2020 after a long and hard-fought battle with cancer. A native of Morganza, Louisiana and a resident of Prairieville, LA., Allen is survived by his wife of 53 years, Flory Contine'

Reynolds; and his two daughters, Georgie and Brandi, and their spouses; along with 9 grandchildren and 6 great grandchildren. Allen proudly served on active duty in the U.S. Army in Fort Belvoir, VA and served the remainder of his commitment in the U.S. Army Reserves. Allen was a career Louisiana civil servant and rose through the ranks to become the Personnel Director for the entire Louisiana Department of Civil Service, where he served with honor and distinction as a staunch advocate for employee/civil servant rights and benefits until his retirement. Upon his retirement from Civil Service, Allen became a very active member of the RSEA Board of Directors and eventually became Executive Director of RSEA from May, 2009 until July, 2010. Upon stepping down as RSEA Executive Director, Allen returned to the RSEA Board and served in a variety of positions, most

notably, as Secretary-Treasurer until his passing in August, 2020. Allen also served a brief stint in a voluntary capacity as Acting Executive Director in 2017 during the search for a new Executive Director. Allen will always be remembered as a great human being and a friend. He was a wonderful man and respected by all who knew him. He will be sorely missed by all, especially by the Board members and staff of RSEA, for his kindness, humility and compassion. In the words of RSEA Immediate Past-President, Bonita Hearne, "My life has been enriched by knowing such a wonderful person."

As the new Office Manager of RSEA, Susan Jandle remembers that Allen trained her and advised her with patience and kindness throughout the past two years. In Susan's words, "Allen was a 'gentle soul' and I will miss him terribly."

"Since I was hired as the Communication & Membership Coordinator at RSEA three years ago, the memory that I hold dearest to my heart about Allen was his sincerity. Whenever he visited the RSEA Office, I was greeted with a huge smile and a hug and he would always ask how the job was going. I will truly miss him, says Linda Price.

Administrative Director Jimmy Anthony remembers Allen as a kind and gentle soul who had the ability to light up a room when he walked in. "I will always remember the smile on his face and the twinkle in his eye. He helped me tremendously when I became the Director of RSEA", says Jimmy.

DUDLEY A. "BUTCH" GAUTREAUX, JR.



Dudley Anthony "Butch" Gautreaux, Jr. age 72 passed away on February 22, 2020. A native of Morgan City, Louisiana, Butch retired in Thibodaux, LA in 2017. Butch is survived by his wife of 51 years, Marilyn Mire Gautreaux, and his two sons, Michael and

Lee, their spouses along with 7 grandchildren. Butch proudly served in the U.S. Navy from 1968-1972 as a 2nd Class Petty Officer. In the early years of his career, Butch was a small business owner for 30 years in Morgan City. Later he became interested in politics and served the people of Louisiana for 16 years in the state legislature representing House District 51 for 4 years and Senate District 21 for 12 years, including a position as Chairman of the Senate Committee on Retirement. He was a true statesman and served admirably as a well-respected problem solver and tireless worker for the citizens of Louisiana. Upon retirement from the legislature in 2012, Senator Butch Gautreaux graciously accepted an appointment to the RSEA Board of Directors as a Director Emeritus in recognition of his body of work in the legislature on behalf of state employees and retirees. Butch continued to serve RSEA with dignity for 8 years in that capacity until his untimely death in 2020. In honor of his accomplishments on behalf of state employees and retirees, Senator Gautreaux will be inducted into the Retired State Employees Association (RSEA) Hall of Fame in November of this year!

OGB UPDATE

OGB ANNUAL ENROLLMENT: WHAT YOU NEED TO KNOW

Annual Enrollment for the 2021 plan year is upon us. The Office of Group Benefits (OGB) would like to update you on a few changes you will need to know going into annual enrollment this year.

The ever changing costs of healthcare requires OGB to occasionally make changes to our health plans in order to continue to provide our members with the coverage they are accustomed to. Therefore, effective January 1, 2021, premium rates for the Pelican and Magnolia plans will increase by 5.5 percent. Vantage Health Plan also will raise their rates by 6 percent. A copy of the premium rates for plan year 2021 can be found on our website, info.groupbenefits.org/premium-rates/.

Due to health concerns stemming from the COVID-19 pandemic, annual enrollment will be a little different this year. The informational meetings will be limited in size and attendees, as well as OGB staff and vendors, will be required to wear a mask. Please call OGB customer service at 1-800-272-8451 to have your name added to the list for the meeting you wish to attend. Our hope is to provide our members with the information they

need in the safest way possible. Please take note of the new locations for the Lafayette and Monroe meetings. Additionally, due to the devastating damage inflicted on the Lake Charles area by Hurricane Laura, we will not be able to host annual enrollment meetings in Lake Charles this year.

Retirees who are unable to attend a meeting or do not have internet access may schedule an appointment with an OGB customer service representative to ask questions and go over the 2021 benefit options. Appointments are available on a first come, first serve basis between 7:00am - 9:00am and 4:30pm - 7:00pm, Monday through Friday. To schedule an appointment, please call OGB customer service at 1-800-272-8451. On the date and time of your scheduled appointment, an OGB customer service representative will call you at the number you provided. Walk-in visits at the OGB offices are by appointment only.
