
Chapter Meetings are being planned for the spring. Dates, times and locations are included in this newsletter. It will be great to have meeting in-person this year after a two-year absence.

## RSEA Legislative & Governmental Affairs Director's Message

This is the latest update on the developments on the Social Security Offsets—the WEP (Windfall Elimination Provision) and the GPO (Government Pension Offset). At this time last year, **U.S. House Bill HR-82 (Rep. Rodney Davis-IL) Social Security Fairness Act of 2021** had 214 co-sponsors. As of RSEA's last quarterly update in September 2022, HR 82 had gathered 305 co-sponsors. This is 15 more signatures than the 290 needed to bring the measure to floor vote prior to the Congressional recess for the mid-term elections. This would have allowed Congress to put the matter on the consensus calendar and bring the matter directly to the House floor for a vote. Unfortunately, in the “wisdom” of the House leadership, the bill was not brought directly to the floor, but was side-tracked to the House Ways and Means Committee. The Ways and Means Committee met and voted on September 20, 2022 and sent the bill (HR -82) without recommendation (or amendments) to the House floor “regular calendar” instead of the “consensus” calendar. This means the House leadership now decides if and when the bill will be brought up for a vote by the full House of Representatives. This has the consequence of slowing the bill down and possibly delaying it until the next session of Congress. Due to the upcoming mid-term election & holiday breaks and other matters, the likelihood of a floor vote is unknown and uncertain for this session of Congress which concludes on January 3, 2023 or just a little over a month away.

In an effort to keep the legislation (HR-82) alive, the lead author, Rep. Rodney Davis filed a “**Discharge Petition**” (HR-1367) requiring 218 in-person signatures on the House Floor while Congress is in session. As of this writing on November 29, 2022, only 32 signatures of the required 218 have been obtained! It still seems like an uphill battle at this point. Thus far, Representatives Graves, Letlow, Higgins and Johnson from Louisiana have signed the Discharge Petition (HR-1367). Reps. Scalise and Carter have not signed the discharge petition, as of this writing. Additionally, besides slowing down the process, this subjects the bill to amendments and still further delays. In its current form, the bill is a total repeal of the WEP and GPO. However, the Ways and Means Committee members were concerned about the high cost of the bill's total repeal of the WEP and GPO, and they may look to lower the cost by only implementing a **partial repeal** of either the WEP or GPO only, and **not a total repeal** of both offsets. The bill is now subject to amendments and further delaying tactics, which is a travesty in my view!

We will continue to monitor this legislation and stay in touch with our Louisiana state congressional delegation (all of whom are currently co-sponsors of HR -82) and keep you informed of any progress on the measure or any other substitute measures for HR-82. There are numerous other competing House measures for modification of the WEP/GPO, just to name a few: 1) HR-5834 (Kevin Brady-TX) Equal Treatment of Public Servants Act of 2021; 2) HR-2337 (Richard Neal-MA) Public Servants Protection and Fairness Act of 2021; and 3) HR-5723 (John

Larson-CT) Social Security 2100: A Sacred Trust. My realistic appraisal of the situation is that the best we can hope for at this point is a partial repeal of the WEP only and a possibly a partial repeal of the GPO as a longshot. There seems to be more focus on the WEP at this time by the leadership of the House Ways and Means Committee. Turning to other matters of interest to our members, RSEA has been contacted by several of our RSEA members regarding the impact of the LASERS one-time supplement payment on their Social Security Benefits. It was reported earlier that the one-time supplemental payment would not in all likelihood impact the retirees' SSA benefits, since it was a non-recurring benefit. Upon learning of this situation, RSEA contacted LASERS legal section and reported this to them. Since that time, LASERS has filed a "complaint" with the Social Security Administration (SSA) on behalf of our members. We are also staying in contact with LASERS and our members to follow-up on this situation. It is suggested that anyone who receives a letter from SSA about this matter should call Social Security and also appeal the matter to SSA in accordance with the guidelines found in the letter from SSA.

LASERS, along with the other three state retirement systems-Teachers, School Employees and State Police, is "working diligently to improve the Cost of Living Adjustment (COLA) mechanism for our retirees, as reported by Ms. Cindy Rougeou, LASERS Executive Director. Proposed legislation is being contemplated for the 2023 session that, if successful would provide COLAs on a more consistent, transparent, and predictable basis. RSEA will be actively monitoring the proposed legislation, and participating with LASERS and the other retiree associations in trying to gain passage of this 2023 proposed legislation. Finally, at its September, 2022 LASERS Board meeting, the LASERS Board of Trustees adopted the June 30, 2022 LASERS Annual Valuation Report and its proposed DROP interest rate of 6.55%. The report awaits final approval by (PRSAC) Public Retirement Systems' Actuarial Committee, scheduled to meet on December 15, 2022. If approved by PRSAC, interest will be posted by LASERS to "old" DROP accounts for the time period July 1, 2021 through June 30, 2022 in the coming months.




Bobby was honored at a ceremony on Friday, Oct. 28, 2022.

### **Mailing Soon: Form 1099-R for 2022**

Form 1099-R for 2022 will be mailed to retirees no later than January 31, 2023. You can check your mailing address online in myLASERS. Please allow up to two weeks for delivery of your 1099-R. If you have not received it by February 7, or if you need to request a duplicate copy, you may access your 1099-R information online through myLASERS. To report an error or request a duplicate be mailed to you, please call LASERS at 225.922.0600 or 1.800.256.3000. Should you have questions regarding your 1099-R, we suggest that you contact your tax advisor.

### **A Power of Attorney May be Right for You**

What is a Power of Attorney (POA)? A POA is a legal document that allows an individual to act on behalf of another person. For many, having a valid POA provides peace of mind in knowing that if you are unable to make decisions for yourself, someone you know and trust will be able to make those decisions on your behalf. Please note that a POA typically includes your financial interests, allowing the designated individual to act on your behalf in the event of your mental or physical incapacity.

There are several types of POAs and various degrees of responsibility that can be delegated. LASERS is unable to speak to anyone other than you regarding your account or accept documents signed by anyone but you unless we have an approved POA on file. Further, LASERS does not accept strictly Medical POAs, as those relate only to healthcare decisions.

We strongly encourage you to contact your attorney as you plan ahead to determine if a POA is right for you. Once you have your POA documents, send in the **original, notarized document** to LASERS to be reviewed and approved by our legal team.

### **2023 Election Year for LASERS Board of Trustees**

Five seats on the LASERS Board are up for a vote in 2023. Two seats are open for retired members and three for active members.

**Nominations will open on March 1 and close on July 11.** Voting occurs in September and October, and the Board certifies election results and announces newly elected Trustees in November. If you are interested in being a candidate in the Board election, nominating petitions and additional election information will be available on the LASERS website soon.

### **Answers to Your Questions Regarding the One-Time Supplemental Payment Potentially Impacting Social Security Benefits**

**Act 656 (SB 5)** passed in the 2022 General Session of the Louisiana Legislature authorizing a **one-time only** supplemental benefit payment for eligible retirees and beneficiaries. LASERS made payments to eligible members on August 15, 2022. We were subsequently made aware that the Social Security Administration (SSA) has corresponded with retirees who receive SSA benefits regarding the impact of the one-time supplemental payment. As such, LASERS has provided answers to your questions regarding this potential impact.

**1. What are the federal offsets?**

Employees who receive a government pension from employment in positions that are not covered by Social Security may have their Social Security benefits reduced under federal provisions called the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO). The WEP is a reduction to your **Social Security retirement benefit** because of the pension earned from your LASERS-covered employment. The GPO is a reduction to your **Social Security spousal or survivor benefits** because of the pension earned from your LASERS-covered employment.

**2. Will the one-time supplemental payment impact my Social Security benefit?**

Potentially. While LASERS stands by its belief that the one-time supplemental payment should not impact your WEP or GPO reduction, some members have received letters from the SSA informing them of a potential change to their reduction. The letters indicate that the impact of the one-time payment will be amortized over the life expectancy of the member. Presumably, this would result in a minimal impact; but LASERS agrees that any reduction, especially one beyond a person's already reduced benefit, is too much.

**3. What has LASERS done regarding this issue?**

We understand your frustration and have filed a complaint with the Social Security Administration on behalf of our members.

**4. What should I do if I receive a letter from the SSA regarding my one-time supplemental payment?**

Call the Social Security Administration. If the letter gives you the option to appeal, we suggest you do so.

**5. Can I return the one-time payment to LASERS?**

If you would like to return your one-time supplemental payment to LASERS, you may do so. However, we strongly suggest you reach out to Social Security to get a better understanding of what your potential reduction is prior to returning the money to LASERS.

You are also invited, as always, to contact your representative in Congress. **Any change to the WEP and GPO reductions must be done on the federal level.** Our System is continuously working with elected officials to reduce or eliminate the federal offsets and we encourage you to contact them as well.


**1. Active employees and non-Medicare retirees:**

### 3. RSEA and the WEP/GPO Rally in Washington DC

I traveled to Washington D.C. to participate in the WEP/GPO rally. We began on Tuesday afternoon (May 17th) meeting in the Lutheran church in the Capitol Hill district. As we gathered and greeted one another, it was a happy occasion since most had been meeting remotely for the past two years. We shared personal stories of how WEP-GPO affects either us or the people we support. On the rally day we began gathering around 8:00 a.m. on Wednesday in the church, for coffee and nutrition bars, distributed visors, repeal buttons, maps of the Senate and House buildings and outlined plans for the day. A brief overview of plans for Wednesday was reviewed. Then we went on our way to lobby visits. Appointments had been made ahead of time, so it was relatively easy to get to appointments on time.

The Rally from 12:00-1:00 was the highlight of the day. The spot was in a shady outdoor space near the Capitol. About 50 people were gathered. Suzie Dixon (CA) and Bette Marafino shared the introductions, while Roger Boudreau (RI) interspersed repeal WEP-GPO chants between speakers.

Senator Whitehouse (D-R.I.), Congressmen Larson, (D-CT), David Cicilline, (D-R.I.) and Seth Moulton (D-MA) spoke about the necessity to repeal WEP-GPO now. A touching highlight to the Rally were the personal stories of the following people: Suzie Dixon (retired teacher- CA), Jane Roth (current teacher- CT), Patrice Earnest- (federal worker-GA), Dicky Wrufel (retired firefighter- ME), Bonnie Ceidel, (retired teacher, spouse- CA), Penny Whitney Asdourian (government employee- ME), Gene Sokolowski (PSAI- VA). The Rally was live-streamed and photographers took pictures of attendees. Press releases were also sent.

Each of the Congressmen and Senators who spoke made a large point of thanking us for our work and helping to get these bills on committee agenda.

Lobby visits continued after the Rally. Because some congressional

offices were not accepting in-person visits, several Zoom meetings were arranged and included participants in D.C. and those back home. Zoom visits to both CT Senators' offices (Blumenthal and Murphy) garnered over 50 participants.

Later in the afternoon, a debriefing was held in the church. We had a chance to talk about our visits. All agreed that the day was successful and continuing work in our respective states needs to be done to make the WEP-GPO repeal a reality in this 117th Congress. Special thanks to the planning committee for their diligence and commitment, Bonnie Ceidel, Suzie Dixon, Dennis Cox, Mary Elia, Dicky Wrufel, Paula Cooper, Roger Boudreau, Julie Horwin, Patrice Earnest, Dianne Winsor and Jane Roth. We are reorganizing and building a stronger coalition. We will keep you updated and ask for your continued help.

4. RSEA was proud to lobby the legislature for passage of SB 5 this year. Since the last LASERS' COLA (cost of living adjustment) was in 2016 and there were insufficient funds in the LASERS Experience Account to fund a COLA this year, the LASERS Board of Trustees sponsored **SB 5 by Senator Ed Price (Primary Author)**. This measure provided for a one-time supplemental lump-sum payment that was equal to the lesser of \$2,000 or the retiree/beneficiary's monthly retirement benefit. To be eligible for this payment, LASERS' retirees must have been at least 60 years of age and must have been receiving a retirement benefit at least one year as of June 30, 2022. The lump-sum benefit payment was made by LASERS to eligible retirees/beneficiaries by September 15, 2022. Of special note, this bill received unanimous support in the Senate (35-0) and in the House of Representatives (96-0)! On behalf of RSEA and its members, I wish to extend our heartfelt thanks and gratitude to the LASERS Board of Trustees and Staff, Senator Ed Price and the entire Louisiana legislature, and Governor John Bel Edwards for their unanimous support of this measure!

Without a doubt, Kent Gonsoulin's Cajun humor was the hit of the show. He had folks laughing from start to end. During our luncheon, we recognized our RSEA Foundation Scholarship recipient and sponsor, Allen Reynolds, our RSEA Hall of Fame inductee, and our Chapter Members of the Year (Mary Ginn - Baton Rouge Chapter, Michael Sawrie - Alexandria Chapter, and Virginia Lee - Monroe Chapter).
